1. As per the advertisement (Janasanyog/571/16) for empanelment of NSDC and SSC affiliated Skill Training Provider under ESTP component of DAY-NULM, following STP s were empanelled –

Moreover as per Clause 5.1 Para 3 of Guideline of ESTP of MoHUA, GoI, limited RFPs called from training partners empanelled under different departments of Govt. of Assam. And after evaluation following 4 nos. of Skill Training Providers are selected with work order details -

2. As per Clause 3 of Guideline of ESTP of MoHUA, GoI the cost and payment norms to Skill Training Providers (STP), Payment to STPs are done in 3 instalments as per following terms of Payment

1st Instalment (30%) - Commencement of training

2nd Instalment (50%) – Training completion and Certification of the candidates

3rd Instalment (20%) - Placement / enterprise development of 70% candidates in the batch and tracking of candidates for 6 months.

However as per provision of the Clause 3 Para 2 of Guideline of ESTP of MoHUA, GoI, ASULMS revised the payment terms and condition to 4 instalment payment for the above mentioned STPs as below -

1st Instalment (30%) - Commencement of training

2nd Instalment (30%) - Training completion and Certification of the candidates

3rd Instalment (20%) - Placement / enterprise development of 70% candidates in the batch and tracking of candidates for 6 months.

4th Instalment (20%) - Post placement tracking of placed candidates

And all the training partners are paid on receiving bills with required documents and endorsement from City Project Officer (CPO) of concerned CMMU and Chairperson of respective Municipal Body as per above payment norms.

Ref : K-12014(21)/1/2018-UPA I(9044566) dtd. New Delhi 01/10/2019 regarding compliance of operational guideline for payment to Skill Training Provider (STPs) under EST&P component of DAY-NULM from Ministry of Housing and Urban Affairs, NULM Division, GoI.

As per Clause 3 Para 2 of Guideline of ESTP of MoHUA, GoI "The first two installments may be based on the commencement of training, completion and certification of the candidate and last 20% may be paid on the placement / enterprise development and tracking of candidates for 6 months."

The training partners can raised the 3rd instalment bill only after placement/ enterprise development of 70% candidates. In most cases STPs were unable to placed 70% of candidates in a particulars batch and therefore they have not submitted 3rd instalment bill to ASULMS till date. So though STPs received the 1st and 2nd instalment bill for training, but 3rd bill payment were pending.
