ORDERS BY THE GOVERNOR OF ASSAM
NOTIFICATION

Dated, Dispur the 30th October, 2017

No.UDD(M)174/2017/34 : In pursuance of the provision made in Para 1.3 of the Mission Document of the Deendayal Antyodaya Yojana - National Urban Livelihoods Mission (DAY - NULM) of the Ministry of Housing & Urban Affairs, Government of India, the Governor of Assam is pleased to notify that the benefits of different components of DAY-NULM will be extended to 'eligible beneficiary' as determined based on the following criteria of vulnerability.

- Occupational Vulnerability** : All Street Vendors and the families having annual income of Rs. 1.00 lakh and below shall be considered in this category.
- Residential Vulnerability** : People who do not have access to land, shelter, basic services etc. In this case, homeless population and slum dwellers in the notified and non-notified slums will be covered.

In the above classification, sections of the population who are subject to greater vulnerability i.e. women, children, the aged, SCs, STs, Minorities, Tea Tribes Community, Safai Karmacharis, victims of riots / anti social activities and differently abled persons shall get attention on a priority basis.

Further, the individuals shall have to submit any of the following Proof of Documents in support of their claim as 'eligible beneficiary'.
